INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this “**Assignment**”) is made and entered into on October 26, 2018, by and between South Cone, Inc. (“**Assignor**”), and Trestles IP Holdings, LLC (“**Assignee**”) (Assignor and Assignee are each hereinafter referred to as a “**Party**,” and collectively, as the “**Parties**”). Capitalized terms used but not defined herein shall have the meanings ascribed thereto in the Purchase Agreement (as defined below).

WHEREAS, the Parties have entered into that certain Asset Purchase Agreement, dated as of October 2, 2018 (the “**Purchase Agreement**”), pursuant to which, on the terms and subject to the conditions set forth in the Purchase Agreement, Assignor agreed to sell, convey, transfer, assign and deliver to Assignee at the Closing, free and clear of all Liens (other than Permitted Liens), all of Assignor’s right, title and interest in, to and under the Business Owned Intellectual Property Rights, including the assets set forth on Attachment A (the “**Assigned IP**”); and

WHEREAS, Assignee wishes to acquire and accept all of Assignor’s right, title and interest in, to and under the Assigned IP, and Assignor wishes to sell, convey, transfer, assign and deliver to Assignee all of such right, title and interest in, to and under the Assigned IP.

NOW, THEREFORE, in consideration of the mutual promises set forth in this Assignment and the Purchase Agreement and other good and valuable consideration, the adequacy and receipt of which are hereby acknowledged, the Parties hereby agree as follows:

1. Transfer of Assigned IP. Assignor does hereby irrevocably sell, convey, transfer, assign and deliver to Assignee and its successors and assigns, and Assignee does hereby acquire and accept, all of Assignor’s right, title and interest in, to and under the Assigned IP throughout the universe and all rights corresponding thereto, in the case of trademarks, together with the goodwill of the business symbolized thereby and appurtenant thereto, and in the case of copyrights including all renewals and extensions thereof, free and clear of all Liens (other than Permitted Liens), together with all income, royalties or payments now or hereafter due or payable in relation to the Assigned IP, and all benefits, privileges, causes of action, common law rights, and remedies relating thereto throughout the world.

2. Subject to Purchase Agreement. Assignor and Assignee acknowledge and agree that the representations, warranties, covenants, indemnities, limitations and other terms contained in the Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the fullest extent provided therein. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern.

3. Authorization. Assignor does hereby authorize and request the (a) United States Library of Congress Copyright Office, and the corresponding entity or agency in any applicable foreign country, to record Assignee as assignee and owner of the entire right, title and interest in and to the copyrights included in the Assigned IP (including those listed on Attachment A), and (b) Commissioners for Patents and Trademarks, and the corresponding entity or agency in any applicable foreign country, to record Assignee as assignee and owner of the entire right, title and interest in and to the patents and trademarks included in the Assigned IP (including those listed on Attachment A).

4. Electronic Transfer, Transfer Forms. Assignor agrees to cooperate with Assignee, at Assignee's cost, to promptly transfer the domain names included in the Assigned IP (including those listed on Attachment A) electronically from Assignor's account to Assignee's account (such that Assignee will be listed as the registrant of such domain names in the WHOIS database) and Assignor shall deliver all passwords, authorization codes or similar information necessary to transfer to Assignee all such domain names.



Assignor does hereby covenant and agree with Assignee to execute and deliver to Assignee and any successors or assigns of Assignee at Assignee's cost such other and further instruments of sale, assignment, transfer, conveyance and delivery and all such further assurances, notices, releases, acquittances and other documents, consents and waivers as may be necessary or reasonably requested by Assignee or any such successors or assigns in order to put them in possession of or vest in them or confirm, evidence, perfect, maintain, enforce or protect their title to and right to use and enjoy the Assigned IP, including, without limitation, all documents necessary to record in the name of Assignee the assignment of the patents and trademarks included in the Assigned IP with the United States Patent and Trademark Office and the copyrights included in the Assigned IP with the United States Copyright Office and, with respect to any equivalent foreign rights, with any other appropriate foreign or international office or registrar, and any transfer documents required by a domain name registrar.

6. Miscellaneous. This Assignment shall be subject to all applicable provisions of Article 13 of the Purchase Agreement.
