**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of November 16, 2018 (this “Release”), is made by Royal Bank of Canada, in its capacity as Collateral Agent (the “Collateral Agent”), in favor of RegionalCare Hospital Partners Holdings, Inc., a Delaware corporation (“RegionalCare”), RCHP – Wilmington, LLC, a Delaware limited liability company (“Wilmington”), Essent Healthcare, Inc., a Delaware corporation (“Essent”), RCHP – Florence, LLC, a Delaware limited liability company (“Florence”), RCHP – Ottumwa, LLC, a Delaware limited liability company (“Ottumwa”), Capella Healthcare, Inc., a Delaware corporation (“Capella”), Kershaw Hospital, LLC, a South Carolina limited liability company (“Kershaw”), and Willamette Valley Medical Center, LLC, a Delaware limited liability company (“Willamette”). Each of RegionalCare, Wilmington, Essent, Florence, Ottumwa, Billings, Capella, Kershaw and Willamette are referred to herein individually as a “Pledgor” and collectively, as the “Pledgors”. Capitalized terms not otherwise defined in this Release shall have the meanings provided or provided by reference in the Trademark Security Agreement (as defined below).

WHEREAS, reference is made to the Collateral Agreement, dated as of April 29, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”) among Pledgors, the Collateral Agent and other parties party thereto;

WHEREAS, pursuant to the Collateral Agreement, Pledgors executed and delivered that certain Trademark Security Agreement, dated as of April 29, 2016 (the “Trademark Security Agreement”), in favor of the Collateral Agent, which was recorded in the records of the United States Patent and Trademark Office on May 3, 2016 at Reel 5784, Frame 0400 (with respect to RegionalCare, as Pledgor), Reel 5783, Frame 0862 (with respect to Wilmington, as Pledgor), Reel 5783, Frame 0759 (with respect to Essent, as Pledgor), Reel 5783, Frame 0847 (with respect to Florence, as Pledgor), Reel 5784, Frame 0693 (with respect to Ottumwa, as Pledgor), Reel 5783, Frame 0830 (with respect to Billings, as Pledgor), Reel 5784, Frame 0773 (with respect to Capella, as Pledgor), Reel 5783, Frame 0779 (with respect to Kershaw, as Pledgor), and on May 10, 2016 at Reel 5787, Frame 0928 (with respect to Willamette, as Pledgor);

WHEREAS, pursuant to the Collateral Agreement and the Trademark Security Agreement, as security for the payment and performance, as applicable, in full of the Secured Obligations, each Pledgor granted and pledged to the Collateral Agent, its successors and permitted assigns, for the benefit of the Secured Parties, a security interest in all of such Pledgor’s right, title and interest in, to and under any and all of the following assets then owned or at any time thereafter acquired by such Pledgor or in which such Pledgor then had or at any time thereafter acquired any right, title or interest (but excluding any Excluded Property): all Trademarks of the United States of America, including those listed on Schedule I attached hereto (collectively, the “Trademark Collateral”); and

WHEREAS, the Collateral Agent acknowledges that the conditions for termination of its security interest in the Trademark Collateral have been met, and accordingly, the Collateral Agent has agreed to execute this Release.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent, without any representation, warranty or recourse of any kind or nature, hereby releases and terminates in its entirety the Trademark Security Agreement and its security interest in and to the Trademark


Collateral, and discharges, quit claims, and relinquishes unto each Pledgor, and re-assigns to each Pledgor, in each case as applicable, any and all right, title or interest it may have in, to, and under the Trademark Collateral of such Pledgor.

THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK, WITHOUT REGARD TO ANY PRINCIPLE OF CONFLICTS OF LAW THAT COULD REQUIRE THE APPLICATION OF ANY OTHER LAW.


