RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of November 13, 2018 (this "Release"), is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, in its capacity as successor collateral agent for the Secured Parties (in such capacity, "Agent"), in favor of TARGUS INTERNATIONAL LLC ("Targus International"), TARGUS US SUB I INC. ("Targus US Sub I"), TARGUS US SUB II INC. ("Targus US Sub II"), TARGUS US LLC ("Targus US"), SENA CASES LLC ("Sena"), TARGUS US NEWCO INC. ("Targus US Newco"), TARGUS CAYMAN LP ("Targus Cayman"), TARGUS CAYMAN GP LIMITED ("Targus Cayman GP"), TARGUS CAYMAN HOLDCO LIMITED ("Targus Cayman Holdco"), TARGUS CAYMAN SUBCO LIMITED ("Targus Cayman Subco"), TARGUS DELAWARE LLC ("Targus Delaware") and TARGUS GROUP US LLC (collectively with Targus International, Targus US Sub I, Targus US Sub II, Targus US, Sena, Targus US Newco, Targus Cayman, Targus Cayman GP, Targus Cayman Holdco, Targus Cayman Subco and Targus Delaware, "Grantors"). Capitalized terms used but not otherwise defined herein shall have the meaningS set forth in the Amended and Restated Trademark Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Targus Group Holdings, Inc., Targus Group International, Inc., Targus, Inc. Targus USA, Inc., Targus Group US LLC and Oten Inc. (collectively, the "Original Grantors") entered into that certain Trademark Security Agreement, dated as of May 21, 2015 (the "Original Trademark Security Agreement") with Wilmington Savings Fund Society, FSB, as collateral agent (in such capacity, the "Original Agent"), pursuant to which the Original Grantors pledged and granted to the Original Agent a security interest in and to all of their right, title and interest in, to and under the trademark collateral referred to therein;

WHEREAS, the Original Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 11, 2015 at Reel 005550 and Frame 0636;

WHEREAS, pursuant to that certain Trademark Security Agreement Assignment and Assumption, dated as of February 3, 2016 (the "Trademark Security Interest Assignment Agreement"), between the Original Agent and the Agent, the Original Agent assigned and delegated to Agent all of its rights, powers (including powers of attorney), benefits, privileges, and duties and interest in, to and under the Original Trademark Security Agreement;

WHEREAS, the Trademark Security Interest Assignment Agreement was recorded with the United States Patent and Trademark Office on February 10, 2016 at Reel 005728 and Frame 00544;

WHEREAS, pursuant to that certain Amended and Restated Trademark Security Agreement, dated as of February 3, 2016 (the "Amended and Restated Trademark Security Agreement"), among the Grantors and the Agent, the Original Trademark Security Agreement was amended and restated in its entirety, without novation, and the Grantors pledged and granted to the Agent a security interest in and to all of their right, title and interest in, to and under the

Trademark Collateral, including without limitation, the trademark registrations and applications listed on Schedule I hereto;

WHEREAS, the Amended and Restated Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 2, 2016 at Reel 005782 and Frame 0218; and

WHEREAS, Grantors have requested and Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in and to the Trademark Collateral.


NOW, THEREFORE, in consideration of the premises, and for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interests created under the Amended and Restated Trademark Security Agreement in the Trademark Collateral, (b) discharge and release its security interest in and to the Trademark Collateral, and (c) reassign any and all rights, title and interest it has in the Trademark Collateral to Grantors.

THIS RELEASE SHALL BE DEEMED TO BE A CONTRACT UNDER THE LAW OF THE STATE OF NEW YORK WITHOUT REGARD TO ITS CONFLICT OF LAWS PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF ANY OTHER LAW.
