**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of November 16, 2018 (the “Effective Date”), is made by **FIDUS INVESTMENT CORPORATION**, a Maryland corporation (in such capacity, the “Administrative Agent”), in favor of **THE WOLF ORGANIZATION, LLC**, a Delaware limited liability company with an address at 20 West Market Street, York, Pennsylvania 17401 (the “Assignor”).

WHEREAS, the Assignor entered into a certain trademark security agreement dated May 29, 2015 (the “Trademark Security Agreement”) with Administrative Agent, notice of which was recorded on June 18, 2015 at the United States Patent and Trademark Office at Reel 5555, Frame 0972.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Assignor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to all of its IP Collateral, including without limitation the trademarks listed in **Schedule A**.


WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such IP Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent hereby releases, terminates and discharges any and all of its interest in the IP Collateral of the Assignor, and assigns, transfers and conveys to Assignor any interest in such intellectual property, including the Security Interest.
