## **RELEASE OF PATENT AND TRADEMARK SECURITY INTEREST**

This RELEASE OF PATENT AND TRADEMARK SECURITY INTEREST (this "Release"), effective as of November 30, 2018, is entered by SHARET LLC, an Illinois limited liability company ("Lender").

Lender confirms the release from such Security Agreements and all of the terms and conditions thereof, all right, title and interest in and to all such Patent Collateral and Trademark Collateral, including such registrations, all associated goodwill, common law rights and any other right or interest therein.

This Release may be executed in any number of counterparts (including electronic transmission), each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.

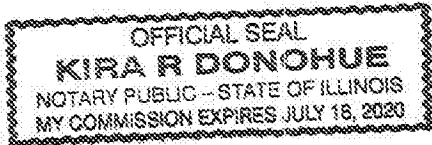
