**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of October 30, 2017 between the Administrative Agent and Kobalt Music Group Limited and that certain Trademark Security Agreement dated as of March 21, 2018 among the Administrative Agent, Kobalt London Limited and Ktech Services Limited (Kobalt Music Group Limited, Kobalt London Limited and Ktech Services Limited, collectively, the “*Grantors*”), the Grantors have granted to the Administrative Agent a security interest in the Trademarks set forth in Schedule 1 (the “*Trademarks*”);

WHEREAS, the above referenced Trademark Security Agreements were, respectively, recorded at Reel 006192, Frame 0948 on October 30, 2017 and Reel 006297, Frame 0654 on March 22, 2018; and

WHEREAS, the Grantors have requested that the Administrative Agent release its lien on the Trademarks.


