**TERMINATION AND RELEASE OF SECURITY INTEREST
IN PATENTS AND TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS**, effective as of November 30, 2018 (“Release”), is made by Bank of America, N.A., as Administrative Agent (“Administrative Agent”) in favor of SP Plus Corporation, a Delaware corporation, USA Parking System, Inc., a Tennessee corporation (each a “Grantor”, and collectively, including any successors or assigns thereof, the “Grantors”) and such other parties as have become “Grantors” under the IP Security Agreement (as defined below).

WHEREAS, pursuant to that certain Amended and Restated Guaranty and Collateral Agreement dated as of February 20, 2015 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Collateral Agreement”), by and among the Grantors, Administrative Agent, and the others party thereto, and the Patent and Trademark Security Agreement dated as of February 20, 2015 (“IP Security Agreement”), by and among the Grantors and Administrative Agent, Grantors granted to the Administrative Agent, for the benefit of the Administrative Agent and the other holders of the Secured Obligations (collectively, the “Secured Parties”), a continuing security interest in, and a right of setoff against, all right, title and interest of Grantors in, to, and under the Patent Collateral and the Trademark Collateral (collectively, including any other assets and properties included therein, the “IP Collateral”); and

WHEREAS, the IP Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on February 23, 2015, at Reel 5464 Frame 0032.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Secured Parties, and Grantors agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Collateral Agreement or IP Security Agreement, as applicable.

SECTION 2. Termination and Release. Administrative Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the IP Security Agreement and the continuing security interest in, and the right to set off against, Grantors’ right, title, and interest in, to, and under the IP Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Collateral Agreement or IP Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Grantors’ expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of Illinois.

SECTION 4. Acknowledgement. The release of security interest granted herein expressly does not include a release of the separate security interest granted pursuant to the Security and Pledge Agreement dated as of November 30, 2018 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time), by and among the Grantors, Bank of America, N.A., in its capacity as administrative agent thereunder, and others party thereto.

IN WITNESS WHEREOF, the Administrative Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Patents and Trademarks to be duly executed as of the date first set forth above.
