## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment"), made effective as of January 23, 2017, is executed and delivered by EMC Corporation, a Massachusetts corporation ("Assignor"), to Open Text Corporation, a corporation incorporated under the federal laws of Canada ("Assignee"). Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in that certain Master Acquisition Agreement (the "Purchase Agreement"), dated as of September 12, 2016, by and among Assignor, EMC International Company, a company organized under the laws of Ireland, EMC (Benelux) B.V., a besloten vennootschap organized under the laws of Netherlands, and Assignee.

WHEREAS, pursuant to and upon the terms and conditions of the Purchase Agreement, Assignor has agreed to assign to Assignee all of the right, title and interest of Assignor in and to the trademark registrations and applications listed on Schedule A attached hereto (the "Assigned Trademarks") and all goodwill associated therewith or symbolized thereby.

NOW, THEREFORE, in consideration of the foregoing recitals, the mutual representations, warranties, covenants and agreements set forth in the Purchase Agreement and the other Transaction Agreements, and other good and valuable consideration, the receipt and sufficiency of which the parties acknowledge, the parties hereby agree as follows:

1. Assignment. Pursuant to and subject to the terms and conditions of the Purchase Agreement, Assignor does hereby sell, convey, assign, transfer and deliver unto Assignee, and Assignee does hereby purchase, acquire and accept from Assignor, all of Assignor's right, title and interest, as of the date hereof, to the Assigned Trademarks, together with the goodwill of the business associated with or symbolized by the Assigned Trademarks, together with the rights as applicable, (A) to sue and recover damages and obtain equitable relief for past, present and future infringement thereof; (B) to collect future royalties and other payments thereunder; (C) to claim priority based on such Assigned Trademarks under the laws of any jurisdiction and/or under international conventions or treaties; (D) to prosecute, register, maintain and defend such Assigned Trademarks before any public or private agency, office or registrar; and (E) to fully and entirely stand in the place of the Assignor, in all matters related to the Assigned Trademarks. Assignor hereby authorizes and requests the Director of the United States Patent and Trademark Office and the empowered officials of all other governments to transfer the Assigned Trademarks to Assignee, as assignee of the entire interest thereto and to record Assignee as the assignee and owner of the Assigned Trademarks and to deliver to Assignee, and to Assignee's attorneys or agents, all official documents and communications as may be warranted by this Assignment.

2. General Provisions. This Assignment does not modify the terms of the Purchase Agreement and nothing contained in this Assignment shall be deemed to supersede, modify, limit, extend, add to, amend or in any way affect any of the rights or obligations of any party under the Purchase Agreement. In the event of a conflict or controversy between the terms of this Assignment and the terms of the Purchase Agreement, the terms of the Purchase Agreement shall control. EXCEPT AS SET FORTH IN THE PURCHASE AGREEMENT, ASSIGNOR MAKES NO REPRESENTATION OR WARRANTY, EXPRESS OR IMPLIED, AT LAW OR IN EQUITY, IN RESPECT OF THE ASSIGNED TRADEMARKS, INCLUDING, WITHOUT

LIMITATION, WITH RESPECT TO MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE, AND ANY SUCH OTHER REPRESENTATIONS OR WARRANTIES ARE HEREBY EXPRESSLY DISCLAIMED. The Laws of the State of Delaware (without reference to its principles of conflicts of law) shall govern the construction, interpretation and other matters arising out of or in connection with this Assignment (whether arising in contract, tort, equity or otherwise). This Assignment may be executed in any number of counterparts, each of which shall be deemed to be an original as against the party that signed it, and all of which together shall constitute one and the same instrument. Delivery of an executed counterpart of a signature page to this Assignment by facsimile or email transmission which includes a copy of the sending party's signature(s) shall be as effective as delivery of a manually executed counterpart of this Assignment. This Assignment is binding upon and inures to the benefit of the parties hereto and their respective successors and assigns.

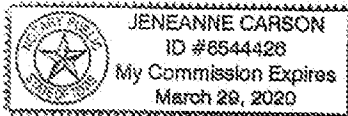

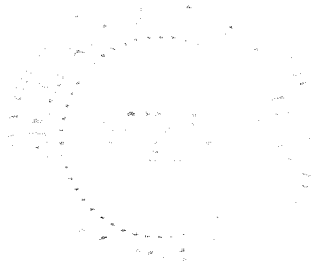

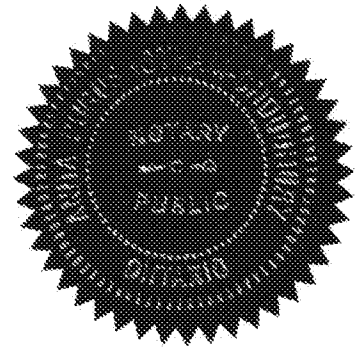
