**SUPPLEMENT TO CONFIRMATORY GRANT OF SECURITY INTEREST IN TRADEMARKS**

This Supplement to Confirmatory Grant of Security Interest in Trademarks (this “Supplement”) is made as of January 28, 2019 by **PIER 1 SERVICES COMPANY**, a Delaware statutory trust (the “Grantor”), in favor of **BANK OF AMERICA, N.A.** (the “Collateral Agent”), for the Credit Parties.

WHEREAS, the Grantor executed and delivered Confirmatory Grant of Security Interest in Trademarks, dated as of April 30, 2014 and recorded with the United States Patent and Trademark Office (the “USPTO”) on April 30, 2014 at Reel 5271, Frame 0212 (the “Initial Grant”) in favor of the Collateral Agent, pursuant to which the Grantor pledged, assigned and granted a security interest in certain Trademarks (as defined therein);

WHEREAS, the Grantor has acquired additional Trademarks and desires to hereby confirm the pledge of, and the grant of a security interest in, the additional Trademarks in favor of the Collateral Agent.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:


1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Initial Grant.
2. Supplement to Exhibit A. Schedule A to the Initial Grant is hereby supplemented, but not replaced, by Schedule A-1 annexed hereto.
3. Miscellaneous:
  - a. Except as provided herein, all terms and conditions of the Initial Grant remain in full force and effect. The Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.
  - b. This Supplement and the Initial Grant cover the entire understanding of the parties with respect to the matters set forth herein and supersede all prior discussions and negotiations hereon.
