**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) is made as of January 28, 2019, by SJC DLF II-I, LLC, acting in its capacity as the agent (in such capacity, including its successor and assigns, the “**Agent**”) and lender party to (a) that certain Loan and Security Agreement, dated as of December 24, 2014 (as amended by that certain First Amendment to Loan and Security Agreement, dated as of April 22, 2015, that certain Consent and Second Amendment to Loan and Security Agreement, dated as of August 31, 2015, that certain Third Amendment to Loan and Security Agreement, dated as of November 16, 2015, that certain Waiver and Fourth Amendment to Loan and Security Agreement, dated as of November 14, 2016, that certain Consent and Fifth Amendment to Loan and Security Agreement, dated as of April 18, 2017, that certain Waiver and Sixth Amendment to Loan and Security Agreement, dated as of December 1, 2017, that certain Consent and Seventh Amendment to Loan and Security Agreement, dated as of January 19, 2018, that certain Eighth Amendment to Loan and Security Agreement, dated as of May 8, 2018, that certain Ninth Amendment to Loan and Security Agreement, dated as of May 16, 2018, that certain Consent and Tenth Amendment to Loan and Security Agreement, dated as of October 3, 2018, and as further amended, amended and restated, supplemented or otherwise modified prior to the date hereof, the “**Loan and Security Agreement**”), by and among FRANKLIN FINANCIAL MANAGEMENT, LLC, a California limited liability company (“**Franklin**”), CROWN BRANDS LLC, an Illinois limited liability company, FOCUS FOODSERVICE, LLC, an Illinois limited liability company, JOHNSON-ROSE CORP., a New York corporation, TOMLINSON INDUSTRIES, LLC, a Delaware limited liability company, CLP FOODSERVICE DISTRIBUTION, INC., a Delaware corporation; CO-RECT PRODUCTS, INC., a Minnesota corporation, the Agent, and the Lenders from time to time party thereto; and (b) that certain Intellectual Property Security Agreement, dated as of December 24, 2014, by and between Franklin, as Pledgor, and the Agent (the “**IP Security Agreement**”), recorded in the United States Patent and Trademark Office (“**USPTO**”) on January 5, 2015 at Reel 5434, Frame 0635. Capitalized terms used herein without definition shall have the meanings assigned in the Loan and Security Agreement and/or the IP Security Agreement.

WHEREAS, pursuant to the IP Security Agreement, the Agent was granted a security interest in and to the Trademarks, including those listed on Schedule A (the “**Subject Trademarks**”);

WHEREAS, Franklin has requested that the Agent terminate and release its security interests in and to the Subject Trademarks, and that the Agent execute and deliver evidence of such termination and release for filing in the USPTO; and

WHEREAS, the Agent has agreed to such termination and release.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent hereby releases and terminates all security interests and other interests it may have in the Subject Trademarks. Franklin or the relevant assignee and current owner of all right, title and interest in the Subject Trademarks are authorized to file this Release with the USPTO and any other governmental authority.


