

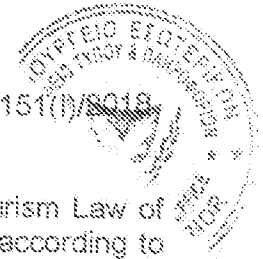

The Renaming of the Ministry of Energy, Commerce, Industry and Tourism Law of 2018 published in the Government Gazette of the Republic of Cyprus according to Section 52 of the Constitution.

No 151(I) of 2018  
THE RENAMING OF THE MINISTRY OF ENERGY,  
COMMERCE, INDUSTRY AND TOURISM LAW OF 2018

The House of Representatives enacts as follows:

- Short title 1. This Law shall be cited as the Renaming of the Ministry of Energy, Commerce, Industry and Tourism Law of 2018.
- Renaming of the Ministry of Energy, Commerce, Industry and Tourism. 2.-(1) The Ministry of Energy, Commerce, Industry and Tourism is hereby renamed Ministry of Energy, Commerce and Industry.  
(2) Wherever in any law or regulation or order reference is made to the "Ministry of Energy, Commerce, Industry and Tourism" and to the "Minister of Energy, Commerce, Industry and Tourism" it shall be deemed to be a reference made to the "Ministry of Energy, Commerce and Industry" and to the "Minister of Energy, Commerce and Industry" respectively.
- Repeal of Law 57(I) of 2013. 3. The Renaming of the Ministry of Commerce, Industry and Tourism Law of 2013 is hereby repealed.
- Entry into force of this Law. 4. This Law shall enter into force on 02 January 2019.
