## INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (this "*Assignment*") is made and entered into as of August 30, 2018, by and between D. & J.F. Cellars, Inc., a Oregon corporation, Greenpatch Farm, Inc., a Washington corporation, and E.G.M., LLC, an Oregon limited liability company (collectively, "*Assignor*") and Stone Wolf Vineyards LLC, a ("*Assignee*"), pursuant to that certain Purchase Agreement, dated as of [August 31, 2018] (the "*Purchase Agreement*"), between Assignor and Assignee and certain other parties thereto.

### RECITALS

WHEREAS, pursuant to the Purchase Agreement, Assignee has agreed to transfer and assign unto Assignor certain intellectual property owned by Assignor;

WHEREAS, pursuant to the terms and conditions of this Assignment and the Purchase Agreement, Assignor desires to assign to Assignee all of Assignee's right, title and interest in, to and under those trademarks listed in Exhibit A (the "*Marks*") and Assignee desires to accept such assignment;

NOW, THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

### AGREEMENT

1. Assignment. For the consideration set forth in the Purchase Agreement, and intending to be legally bound, Assignor hereby assigns, sells, transfers, and conveys unto Assignee and its successors and assigns, Assignor's entire right, title, and interest in and to the Marks, together with that part of the good will of Assignor's business connected with the use of and symbolized by the Marks and the registrations thereof, and the entire right, title, and interest in and to any and all claims and demands Assignor may have either at law or in equity arising out of past, present, or future infringement of the Marks, and including all common-law and other rights in the Marks; and

2. Further Actions. Assignor will (a) execute and deliver such further instruments and documents and take such other actions as Assignee may reasonably request in order to effectuate the purposes of this Assignment and to carry out the terms hereof, including executing appropriate assignments complying with foreign law, and (b) take, or cause to be taken, all actions, and to do, or cause to be done, all things reasonably necessary, proper or advisable under applicable laws, regulations, and agreements, or otherwise to consummate and make effective the transactions contemplated by this Assignment.

3. Authorization. Assignee hereby authorizes the Commissioner of Patents and Trademarks and other empowered officials of the United States Patent and Trademark Office to record the transfer of the Marks to Assignee as purchaser and assignee of Assignor's entire right, title and interest therein, and to issue to Assignee all registration certificates and other items referred to above which may issue with respect to the Marks.


4. Successors and Assigns. The rights and obligations of the parties hereto shall inure to the benefit of, and shall be binding upon, the parties hereto and their respective permitted successors and assigns.

5. General. Assignor and Assignee acknowledge and agree that the terms of the Purchase Agreement, including the representations, warranties, covenants, agreements and indemnities, shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms of this Assignment, the terms of the Purchase Agreement shall govern. This Assignment may be executed in any number of counterparts, all of which together shall constitute one and the same document. A photocopied or facsimile signature shall be deemed to be the functional equivalent of a manually executed original for all purposes.

IN WITNESS WHEREOF, the parties hereto have caused this Agreement to be executed as of the date first written above by their respective officers thereunto duly authorized.


