**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

This Release of Security Interest in Intellectual Property, dated as of December 7, 2018 (this “**IP Collateral Release**”), is made by **MIDCAP FINANCIAL TRUST**, a Delaware statutory trust, as Agent for the Lenders (in such capacity, “**Agent**”), in favor of **MINUET DIAGNOSTICS, INC.**, a Delaware corporation (“**Minuet**”), **CYNOGEN INC.**, a Delaware corporation (“**Cynogen**” and together with Minuet, collectively, the “**Subsequent Grantors**”), and **GENOPTIX, INC.**, a Delaware Corporation (“**Genoptix**” and together with Subsequent Grantors, collectively, the “**Grantors**”):

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of March 1, 2017 (as the same may have been amended, modified, restated, replaced or supplemented from time to time, the “**Genoptix IP Security Agreement**”; capitalized terms used herein have the definition provided for in the Original IP Security Agreement), recorded with the United States Patent and Trademark Office on March 2, 2017 at Reel/Frame No. 5999/0209 (Trademarks), and with the United States Copyright Office on March 3, 2017 at Volume 9944, Document 780 (Copyrights), Genoptix granted Agent, on behalf of the Lenders, a security interest in and to all of its right, title and interest in all of Genoptix’s intellectual property, including those listed on Exhibits A through D thereto;

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of April 6, 2018 (as the same may have been amended, modified, restated, replaced or supplemented from time to time, the “**Subsequent Grantors’ IP Security Agreement**”; and together with the Original IP Security Agreement, the “**IP Security Agreements**”), recorded with the United States Patent and Trademark Office on April 9, 2018 at Reel/Frame No. 6309/0604 (Trademarks), Subsequent Grantors granted Agent, on behalf of the Lenders, a security interest in and to all of its right, title and interest in all of Subsequent Grantor’s intellectual property, including those listed on Exhibits A through D thereto;

WHEREAS, the Grantors have requested that Agent release its security interest in and to the copyright assets as more particularly described on Schedule A attached hereto (the “**Released Copyrights**”).

WHEREAS, the Grantors have requested that Agent release its security interest in and to the trademark assets as more particularly described on Schedule B attached hereto (the “**Released Trademarks**”).

WHEREAS, the Grantors have requested that Agent release its security interest in and to the various intellectual property assets set forth in Sections (a) through (i) of each IP Security Agreement (together with the Released Patents and Released Trademarks, the “**Released IP Collateral**”).

NOW, THEREFORE, Agent, without recourse, representation or warranty and at Grantors’ sole cost and expense, hereby releases all of its right, title and interest in and to the Released IP Collateral.


