TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is made this 30th day of November, 2018 (the "Release Date") by Multiplier Capital, LP (the "Secured Party"), for the benefit of PlumChoice, Inc., a Delaware corporation ("PlumChoice"), and PlumChoice Business Services, Inc., a Delaware corporation (collectively, the "Debtors").

WHEREAS, the Debtors have entered into that certain Loan and Security Agreement, dated as of July 26, 2013 with Secured Party (as at any time prior to the date hereof amended, supplemented or otherwise modified, the "Credit Agreement");

WHEREAS, PlumChoice has entered into that certain Intellectual Property Security Agreement, dated as of July 26, 2013 with Secured Party (as at any time prior to the date hereof amended, supplemented or otherwise modified, the "Security Agreement"), pursuant to which the PlumChoice granted to the Secured Party a security interest in PlumChoice's Intellectual Property (as defined in the Security Agreement), including, without limitation, (i) the trademarks and servicemarks listed on Exhibit A attached hereto, whether registered or not, and all applications to register and registrations of the same and like protections, and the entire goodwill of the business of Debtors connected with and symbolized by such trademarks, (ii) all rights to recover for past or future infringement of any of the foregoing, (iii) all right, title and interest in and to any and all present and future license agreements with respect to any of the foregoing, and (vi) all present and future accounts, accounts receivable and other rights to payment arising from, in connection with or relating to any of the foregoing (the "Marks");

WHEREAS, Secured Party has filed with the United States Patent and Trademark Office (the "USPTO") notices of security interests in the Marks; and

WHEREAS, the Debtors have paid all outstanding amounts currently owing under the Credit Agreement and the other financing documents executed in connection therewith and has requested that the Secured Party release its security interest in the Marks.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party agrees as follows:

1. Release of Security Interest. Effective as of the Release Date, Secured Party hereby irrevocably and forever terminates, releases and discharges any and all security interests in the Marks granted by the Debtors under the Security Agreement and Credit Agreement.
2. Recordation of Release. The Secured Party understands and agrees that this Release may be recorded by or for the Debtors with the USPTO.
3. Further Actions. Secured Party further agrees to execute any other documents and take any further action reasonably necessary in any state, country or jurisdiction that the Debtors may reasonably require to effect the intent and purpose of this Release, provided that all

such documents are to be prepared by counsel to the Debtors and the cost and expense of such documents and actions shall be borne solely by the Debtors.

4. Capitalized Terms. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Credit Agreement and/or the Security Agreement, as applicable.
