DEED OF ASSIGNMENT OF TRADE MARK RIGHTS

PARTIES

WAIRAU RIVER WINES LIMITED, a New Zealand company, of Giffords Road, RD 3, Blenheim, NEW ZEALAND (**Assignor**)

ROSE FAMILY ESTATE LIMITED, a New Zealand company, c/- WK Advisors and Accountants Limited, 2 Alfred Street, Mayfield, Blenheim 7201, NEW ZEALAND (**Assignee**)

INTRODUCTION

- A. The Assignor is the owner of the Trade Marks.
- B. The Assignor has agreed to assign to the Assignee, and the Assignee has agreed to accept, the Trade Mark Rights on the terms and conditions of this deed.

COVENANTS

1. DEFINITIONS

In this deed, including the Introduction, the following words will have the following meanings:

Copyright means any and all copyright, and all rights in the nature of copyright, in the Trade Marks in all forms of stylisation in which the Trade Marks have been used;

Effective Date means the date on which this deed has been signed by both parties;

Goodwill means the goodwill symbolised by and associated with the Trade Marks, including the whole of the goodwill arising from the use of the Trade Marks, but not the whole of the goodwill of the business of the Assignor;

Trade Mark Rights means the Trade Marks, Copyright and Goodwill; and

Trade Marks means the trade marks, and any registrations or applications for the trade marks set out in the Schedule.

2. ASSIGNMENT


- 2.1 **Assignment:** In consideration of the sum of NZ\$1.00 paid by the Assignee to the Assignor and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the Assignor, the Assignor hereby transfers and assigns to the Assignee from the Effective Date absolutely all of its rights, title and interest in and to the Trade Mark Rights, including without limitation any and all rights under common law and any and all unregistered rights in and to the Trade Marks
- 2.2 **Rights of action:** The assignments effected by clause 2.1 include, without limitation, the assignment and transfer of all rights of action, powers and benefits arising from the ownership of the Trade Mark Rights including, without limitation, the right to sue for damages and other legal and equitable remedies in respect of all causes of action arising before, on or after the date of this deed.

3. GENERAL

- 3.1 **Further actions:** If requested by the Assignee the Assignor will, at the Assignee's expense, execute all documents, give such assistance and do all other acts and things as may be necessary or desirable to:
- (a) record this assignment on any trade marks register anywhere in the world;
 - (b) prosecute, maintain, renew, enforce and defend the Trade Mark Rights; or
 - (c) otherwise carry out the purposes and intent of this deed.
- 3.2 **Waiver:** No failure or delay by any party in exercising any right, power or privilege under this deed will operate as a waiver of such right, power or privilege, nor will any single or partial exercise preclude any other or further exercise of any right, power or privilege under this deed.
- 3.3 **Counterparts:** This deed may be executed in any number of counterparts (including facsimile copies or electronically scanned copies) all of which, when taken together, will constitute one and the same instrument. A party may enter into this deed by executing any counterpart.
- 3.4 **Governing law:** The formation, validity, construction and performance of this deed will be governed by and construed in accordance with the laws of New Zealand. The parties irrevocably agree that the courts of New Zealand will have non-exclusive jurisdiction to hear and determine all disputes under or in connection with this deed






