RELEASE OF AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT

This **TRADEMARK RELEASE** is made as of January 31, 2019 (“Effective Date”) executed by Capital One, National Association (in such capacity, together with its successors and permitted assigns, “Agent”, in favor of **FFP HOLDCO, LLC** (“FFP Holdco”), **BIOLOGICTX, LLC** (“BiologicTx”) and **SUNSHINE INFUSION SERVICES INC.** (“SIS” and together with FFP Holdco and BiologicTx, each individually a “Grantor” and collectively the “Grantors”)

WHEREAS, pursuant to the terms and conditions of that certain Amended and Restated Trademark Security Agreement (the “Trademark Security Agreement”) by the Grantors in favor of the Agent, dated as of October 8, 2015, the Grantors granted to Agent a continuing security interest in and to all of the Grantors’ right, title and interest in all trademarks and trademark intellectual property licenses thereof (collectively the “Trademark Collateral”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 12, 2015 at Reel 5643, Frame 0016;

WHEREAS, pursuant to that certain Omnibus Agency Transfer Agreement by and between General Electric Capital Corporation (the “Retiring Agent”) and Healthcare Financial Solutions, LLC (the “Successor Agent”), Retiring Agent assigned and transferred to Successor Agent and its successors and assigns, all of its rights, title and interest to the Trademark Collateral under that Trademark Security Agreement pursuant to that certain Assignment of Intellectual Property Security Agreement (“Assignment Agreement”), dated as of November 17, 2015 entered into by the Successor Agent and the Retiring Agent;

WHEREAS, the Assignment Agreement was recorded with the United States Patent and Trademark Office on November 20, 2015 at Reel 5673, Frame 0586; and

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Trademark Collateral to the Grantors as set forth on Schedule I attached hereto (the “Released Trademarks”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby terminates, cancels and releases any and all security interests or liens it has against the Released Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademark Collateral, and grants, assigns and conveys, without recourse or warranty, to the Grantors all of their rights, title and interest in the Released Trademarks.
