**RELEASE OF GRANT OF SECURITY INTEREST IN PATENTS, TRADEMARKS, SERVICE  
MARKS AND COPYRIGHTS**

This RELEASE OF GRANT OF SECURITY INTEREST IN PATENTS, TRADEMARKS, SERVICE MARKS AND COPYRIGHTS ("Release") is made and effective as of December 21, 2018 and granted by OWL ROCK CAPITAL CORPORATION, in its capacity as Agent (the "Agent") under the agreements listed on Exhibit A attached hereto (the "IP Security Agreements"), in favor of BLUE RIBBON, LP, a Texas limited partnership (the "Grantor"), and its successors, assigns and legal representatives. Capitalized terms used but not defined herein shall have the meanings ascribed to them in the IP Security Agreements, as applicable.

WHEREAS, pursuant to the IP Security Agreements, the Grantor pledged and granted to the Agent a security interest in and to all of the right, title and interest of such Grantor in, to and under the IP Collateral (as defined below);

WHEREAS, the Grantor has requested that the Agent enter into this Release in order to effectuate, evidence and record the release and reassignment of any and all right, title and interest the Agent may have in the IP Collateral (as defined below) pursuant to the IP Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby states as follows:

**1. Release of Security Interest.** Agent, its successors, legal representatives and assigns, hereby terminates, releases and discharges any and all security interests that it has pursuant to the IP Security Agreements in any and all right, title and interest of the Grantor, and reassigns to the Grantor any and all right, title and interest that it may have, in, to and under the following (collectively, the "IP Collateral"):

- (a) Any and all Patents, Trademarks and Copyrights of the Grantor (including, but not limited to, the Patents, Trademarks and Copyrights referred to on Exhibit B hereto); and
- (b) The Patents, Trademarks and Copyrights set forth on Exhibit B hereto, regardless of whether granted by Grantor or by another Pledgor pursuant to the IP Security Agreements.


**2. Further Assurances.** Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

**3. Governing Law.** This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).
