**PARTIAL RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Partial Release of Security Interest in Trademarks (“Trademark Release”) is made as of January 31, 2019, by **CREDIT SUISSE INTERNATIONAL**, an England limited liability company (the “Collateral Agent”) in favor of **AVAST SOFTWARE S.R.O.**, a Czech Republic limited liability company with an address at Pikrtova 1737/1A, Prague 4, Nusle, Postal Code 140 00, Czech Republic. (the “Grantor”).

W I T N E S S E T H:

WHEREAS, AVG Netherlands B.V. (“Original Grantor”) entered into that certain trademark security agreement dated January 27, 2017 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on January 27, 2017 at the United States Patent and Trademark Office at Reel 5975, Frame 0915.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Original Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to its trademarks, including the trademarks listed in Schedule 1. Such trademarks, among others, were assigned to Grantor, notice of which was recorded on May 25, 2018 at the United States Patent and Trademark Office at Reel 6390, Frame 0074.


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest solely in the trademarks listed in Schedule 1 (the “Trademarks”) as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby, effective upon the sale by the Grantor of the Trademarks, releases, terminates and discharges any and all of its interest in the trademarks listed in Schedule 1 hereto, and assigns, transfers and conveys to the Grantor any interest in such intellectual property, including the Security Interest.
