## **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of February 4, 2019 (“Release”), is made by Bank of America, N.A., as Collateral Agent (“Collateral Agent”) in favor of Transworld Systems Inc., a California corporation (“Pledgor”).

**WHEREAS**, pursuant to that certain Security Agreement dated as of October 31, 2014 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) by and among the Pledgor, Collateral Agent, and others party thereto, and the Trademark Security Agreement dated as of May 22, 2018 by and among the Pledgor and Collateral Agent (“Trademark Security Agreement”), Pledgor granted to the Collateral Agent, for the benefit of the Secured Parties, a lien on and security interest in and to all of its right, title and interest in, to, and under all the Trademarks of the Pledgor listed on Schedule I attached to the Trademark Security Agreement, all Goodwill associated with such Trademarks, and all Proceeds of any and all of the foregoing (other than Excluded Property) (collectively, the “Trademark Collateral”); and

**WHEREAS**, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on May 24, 2018 at Reel 6335 Frame 0867.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, on behalf of the Secured Parties, and Pledgor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement.

**SECTION 2. Termination and Release.** Collateral Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the lien on and security interest in and to Pledgor’s right, title and interest in, to, and under all the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Trademark Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Pledgor’s expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York, without regard to conflicts of law principles that would require the application of the laws of another jurisdiction.

IN WITNESS WHEREOF, the Collateral Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
