BANK OF THE OZARKS LITTLE ROCK, ARKANSAS


On May 10, 2018, Bank of the Ozarks, Little Rock, Arkansas, submitted to the Bank Commissioner a proposed amendment to its Articles of Agreement and Incorporation to which this Certificate is attached. Said application for charter amendments having been on file with the Bank Commissioner for more than seven days, and no protest on file against the application, it was submitted for approval or disapproval to each member of the State Banking Board through the mailing procedure provided in A.C.A. § 23-46-402(g), The Arkansas Banking Code of 1997.

Paragraph (a) of Article I of the Amended and Restated Articles of Incorporation of the Bank are hereby amended in its entirety to read as follows:

- (a) The name of the Bank is Bank OZK, effective July 16, 2018

At least four members of the Board having approved the proposed charter amendment, it is ordered by the State Banking Board, with the concurrence of the State Bank Commissioner, that the proposed charter amendment is hereby approved.


