DECLARATION OF RELEASE OF
SECURITY INTEREST

WHEREAS, DecisionOne Corporation, a Delaware corporation ("Owner"), is the current owner of record of the following U.S. Trademark Registrations:

- 1) EXPERTONE, Reg. #2,268,621
- 2) LOGISTICSONE, Reg. #2,273,902
- 3) NETWORKONE, Reg. #2,268,620

hereinafter the "Trademarks"; and


WHEREAS, on March 11, 2005, Owner, the then owner of 100% of the capital stock of Properties Development Corporation ("PDC"), a Delaware corporation, pursuant to the provisions of the General Corporation Law of the State of Delaware and by resolution of its board of directors, determined to and did consolidate its subsidiary structure by effecting a merger of PDC with and into itself, with Owner as the surviving entity;

WHEREAS, on May 13, 2005, Owner assigned a security interest in the Trademarks to Cerberus Partners, L.P. (a previous investor in Owner), which security agreement ("Security Agreement #1") was recorded with the U.S. Patent and Trademark Office on May 19, 2005, at Reel 003087, Frame 0655 against the Trademarks; and

WHEREAS, on and as of June 30, 2010, Cerberus Partners, L.P. sold its interest in the Owner.

NOW THEREFORE, upon knowledge and belief, Security Agreement #1 is no longer a valid lien against the Trademarks and should be recorded as released.
