**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
BLOOD SYSTEMS, INC.**

Pursuant to the provisions of A.R.S. §10-11006, the undersigned nonprofit corporate adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the nonprofit corporation is Blood Systems, Inc. (the "Corporation"), ACC File Number 00389959.
2. This Amendment to the Articles of Incorporation amends a provision of the Articles of Incorporation of the Corporation filed with the Arizona Corporation Commission on September 17, 1943, as amended (the "Articles of Incorporation"), as follows:
 - a. Article I of the Articles of Incorporation is hereby amended to change the name:

"ARTICLE I

Name. The name of this nonprofit corporation is Vitalant."

- b. Except as expressly amended herein, all other provisions of the Articles of Incorporation of this Corporation shall remain unchanged and in full force and effect as filed with the Arizona Corporation Commission.
3. This Amendment was duly adopted on the 27th day of April, 2018, by act of the Board of Trustees of the Corporation in accordance with the applicable provisions of Sections 10-11001 through 10-11009 of the Arizona Revised Statutes. Member action was not required.
4. *Delayed effective date:* Pursuant to A.R.S. §10-3123, the effective date of this Amendment shall be September 24, 2018.
