Mercer Road Corp., a corporation organized and existing under the laws of the State of Delaware (“Parent”), DOES HEREBY CERTIFY to the following facts relating to the merger (the “Merger”) of Overtone Studio, Inc., a corporation organized and existing under the laws of the State of Delaware (“Subsidiary”) into Parent:

FIRST: That Parent was organized on January 9, 2013, pursuant to the General Corporation Law of the State of Delaware, the provisions of which permit the merger of a corporation organized and existing under the laws of the State of Delaware with a corporation organized and existing under the laws of the State of Delaware.

SECOND: That Subsidiary was organized on the March 22, 2017, pursuant to the General Corporation Law of the State of Delaware, the provisions of which permit the merger of a corporation organized and existing under the laws of the State of Delaware with a corporation organized and existing under the laws of the State of Delaware.

THIRD: That Parent owns at least 90% of the outstanding shares of capital stock of Subsidiary.

FOURTH: The Merger shall become effective upon the filing of this Certificate of Ownership and Merger. The surviving corporation in the Merger is Parent. Upon the effectiveness of the filing of this Certificate of Ownership and Merger, the Certificate of Incorporation of Parent shall remain the Certificate of Incorporation of the surviving corporation in the Merger.

FIFTH: That the Board of Directors (the “Board”) of Parent pursuant to resolutions adopted by unanimous written consent on January 28, 2019 authorized the officers of Parent to merge Subsidiary into Parent as contemplated by this Certificate of Ownership and Merger.

SIXTH: That the proposed Merger has been adopted, approved, certified, executed and acknowledged by Parent in accordance with the laws of the State of Delaware, under which it was organized.

SEVENTH: The executed Agreement and Plan of Merger (the “Merger Agreement”) is on file at the principal place of business of the surviving corporation. The address of the principal

place of business of the surviving corporation is 492 Old Connecticut Path, Framingham, MA 01701.

EIGHTH: A copy of the Merger Agreement will be furnished by the surviving corporation, on request and without cost, to any stockholder of any constituent corporation to the Merger.
