**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “*Termination and Release*”) is dated as of November 21, 2018 by **SILICON VALLEY BANK** (the “*Administrative Agent*”), in favor of **HEALTHLINE MEDIA, INC.**, a Delaware corporation (“*Healthline Media*”) and **EVERYDAYFAMILY, INC.**, a Nevada corporation (“*EverydayFamily*”, together with Healthline Media, each individually and collectively, jointly and severally, the “*Grantor*”).

WHEREAS, Grantor executed and delivered an Intellectual Property Security Agreement, dated as of April 17, 2018 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Agreement*”), granting and pledging to the Administrative Agent a security interest in all of Grantor’s right, title and interest in, to and under the Intellectual Property collateral, which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on April 17, 2018, at Reel 6317, Frame 0322;

WHEREAS, Grantor has requested that Administrative Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Intellectual Property collateral as herein provided; and

WHEREAS, Grantor has requested that the Administrative Agent provide a document suitable for recording with the USPTO to evidence the release of the Administrative Agent’s security interests in and liens on the Intellectual Property collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby:


1. terminates the Agreement and releases, terminates and discharges all liens on and security interests in Grantor’s right, title and interest in, to and under the Intellectual Property collateral, and all goodwill associated therewith, including those trademarks and trademark applications identified in Schedule I hereto and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.

THIS TERMINATION AND RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK (INCLUDING, WITHOUT LIMITATION, SECTION 5-1401 OF THE GENERAL OBLIGATIONS LAW) WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES.
