## RELEASE OF TRADEMARK SECURITY AGREEMENT

This **RELEASE OF TRADEMARK SECURITY AGREEMENT** (the "Release"), dated as of February 4, 2019, is made by Antares Capital LP, a Delaware limited partnership, as Agent (the "Agent"), pursuant to the Credit Agreement dated as of September 21, 2015 (as amended, restated supplemented, or otherwise modified from time to time, the "Credit Agreement") and the Guaranty and Security Agreement dated as of September 21, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"). Capitalized terms used herein without definition are used as defined in the Credit Agreement and Security Agreement.

### WITNESSETH

WHEREAS, Parlec, LLC (the "Grantor") is a party to the Credit Agreement and the Security Agreement;

WHEREAS, pursuant to the Credit Agreement and the Security Agreement, the Grantor executed and delivered to the Agent that certain Trademark Security Agreement dated as of April 11, 2017 (the "Trademark Security Agreement") which was recorded with the United States Patent and Trademark Office on April 18, 2017 at Reel 6035, Frame 0967 pursuant to which the Grantor granted to the Agent a Lien on and security interest in its Trademark Collateral (as defined in the Trademark Security Agreement); and


WHEREAS, as of the date hereof, all of the obligations secured by the security interest granted under the Trademark Security Agreement have been paid, performed, satisfied and discharged in full and, in connection therewith, the Grantor has requested that the Agent release its lien on and security interest in and to all of its right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent hereby **DISCHARGES, TERMINATES and RELEASES**, without recourse, representation or warranty, its security interest in all right, title and interest in and to the Trademark Collateral, including, without limitation, the Trademark registrations and Trademark applications set forth in Schedule I attached hereto and incorporated herein by reference. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Agent may have obtained in, to and under the Trademark Collateral under the Credit Agreement and the Security Agreement.
