GENERAL TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment"), entered into this 27th day of December, 2018, is made by and between **Johnson & Johnson**, a New Jersey corporation with its place of business at One Johnson & Johnson Plaza, New Brunswick, NJ 08933 ("Assignor") and **RoC Opco LLC**, a Delaware limited liability company ("Assignee");

WHEREAS, Cilag GmbH International, a Swiss Company with its place of business at Gubelstrasse 24, Zug, Switzerland ("Seller") and Assignee entered into an Asset Purchase Agreement, dated as of the date hereof (the "APA"), pursuant to which, among other things, Seller agreed to, and agreed to cause its Affiliates to, sell, convey, assign and transfer to Assignee, and Assignee agreed to purchase, acquire and accept from Seller or its Affiliates, among other assets, the Trademarks that are part of the Transferred IP and the Transferred Other Trademarks (as defined in the APA), hereinafter referred to as the "Assigned Trademarks".

WHEREAS, Assignor desires to transfer and assign to Assignee, and Assignee wishes to acquire and assume from Assignor, the Assigned Trademarks set forth in Exhibit A hereto upon the terms and subject to the conditions set forth in the APA.

NOW, THEREFORE, for the consideration set forth in the APA and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Unless otherwise defined herein, all capitalized terms used in this Assignment shall have the respective meanings ascribed to them in the APA.

2. Assignor does hereby irrevocably sell, convey, assign and transfer to Assignee, effective as of the date hereof, and Assignee hereby accepts, all of Assignor's right, title and interest in, to, and under the Assigned Trademarks, including any common law rights associated therewith, together with the goodwill, if any, of the Business associated with the use of and symbolized by the Assigned Trademarks, and all the applications and registrations therefor depicted in Exhibit A, and all rights to (i) bring an action, whether at law or in equity, for past, present or future infringement or unauthorized use of the Assigned Trademarks against any third party in the applicable jurisdiction, (ii) any proceeds, benefits, privileges, causes of action, and remedies solely relating to the Assigned Trademarks and (iii) recover damages, profits and injunctive relief for all past, present or future infringement or unauthorized use of the Assigned Trademarks. The same to be held and enjoyed by Assignee for its own use and enjoyment and the use and enjoyment of its successors, assigns and other legal representatives as fully and entirely as the same would have been held and enjoyed by Assignor if this APA and sale had not been made, as assignee of its entire right, title and interest therein, including without limitation, all rights in and to all income, damages and payments now or hereafter due or payable with respect thereto, and all causes of action, whether in law or in equity, with respect thereto.

3. Subject to the terms set forth in the APA, Assignee shall be responsible for and shall pay all costs relating to the registration, maintenance and prosecution of the Assigned Trademarks, including payment of any associated fees therefor.

4. Subject to the terms set forth in the APA, Assignor will execute and deliver, and shall cause its Affiliates to execute and deliver, as necessary, such other documents as Assignee may reasonably require in order to vest title in the Assigned Trademarks set forth on Exhibit A in Assignee, and Assignee shall be solely responsible, including for all expenses relating thereto, for the preparation of such documents and filing the same with the respective Intellectual Property Office to vest title in Assignee.

5. Assignor acknowledges and agrees that the representations, warranties, covenants, agreements and indemnities contained in the APA shall not be superseded hereby, but shall remain in full force and effect to the full extent provided therein. To the extent that any provision of this Assignment is inconsistent or conflicts with the APA, the provisions of the APA shall control.

6. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, and together shall constitute one and the same agreement and shall become effective on the date hereof. This Assignment, following its execution, may be delivered via electronic mail or other form of electronic delivery, which shall constitute delivery of an execution original for all purposes.




