Affidavit of Hillary J. Wucherer Regarding Release of Trademark Liens

I, Hillary J. Wucherer, being first duly sworn, on oath do hereby state that:

1. I am an attorney with the law firm of Quarles & Brady LLP and a member of the State bar of Wisconsin. I represent Aquion, Inc. (the "Company"), the owner by assignment of Trademark Registration No. 1942751 (the "Trademark"). I am authorized to make this affidavit on the Company's behalf. This affidavit is based on matters I know of my own personal knowledge, as well as on information provided to me by employees of Quarles & Brady LLP and employees of the Company, who gathered such information under my direction and control from publicly available information and from books and records of the Company maintained in the ordinary course of business.

2. I make this affidavit in support of the Company's request that the liens recorded by Ares Capital Corporation and General Electric Capital Corporation against the Trademark be released on the grounds that the underlying debts to the lenders have been satisfied.

3. On December 23, 2005, one of the prior owners of the Trademark -- AWTP, LLC -- granted liens to Ares Capital Corporation (the "Ares Lien") and to General Electric

Capital Corporation (the "GE Lien") in the Trademark. The GE Lien was recorded with the US Patent and Trademark Office at Reel/Frame 3220/0866 on January 3, 2006 and the Ares Lien was recorded with the US Patent and Trademark Office at Reel/Frame 3220/0852 on January 4, 2006.

4. To perfect their respective liens in the Trademark, Ares Capital Corporation and General Electric Capital Corporation were each required under the Uniform Commercial Code to record the lien with the State where AWTP, LLC was located or incorporated. As AWTP, LLC was located in Illinois and incorporated in Delaware, the lien had to be recorded with either the Illinois Secretary of State or the Delaware Secretary of State. Every five years thereafter, Ares Capital Corporation and General Electric Capital Corporation were required under the Uniform Commercial Code to file continuation statements with the Illinois Secretary of State or the Delaware Secretary of State, to continue the perfection in their respective liens in the Trademark.


5. On information and belief, or before December 4, 2013, Aquion, Inc. paid off its obligations to Ares Capital Corporation and General Electric Capital Corporation and the Ares Lien and the GE Lien were released.

6. No continuation statement by Ares Capital Corporation or General Electric Capital Corporation is currently recorded against AWTP, LLC with the Illinois Secretary of State or the Delaware Secretary of State. In addition, no continuation statement by Ares Capital Corporation or General Electric Capital Corporation is currently recorded against the Company with the Illinois Secretary of State (where the Company is located) or with the Delaware Secretary of State (where the Company is incorporated).

7. Accordingly, based on the Company's knowledge and the record of Uniform Commercial Code filings, it appears that the debts were paid by Aquion, Inc. and that the Ares Lien was released by Ares Capital Corporation and the GE Lien was released by General Electric Capital Corporation.


