## TRADEMARK ASSIGNMENT

WHEREAS, The Voris Communication Company, Inc., DBA Kelmscott Communications, an Illinois corporation, having offices at 1665 Mallette Road, Aurora Illinois 60505 (“Assignor”), is the record owner of the entire right, title and interest in and to United States Trademark Registration No. 2,372,814 (U.S. Serial No. 75/787,334) for KELMSCOTT (“Trademark”).

- (a) the entire right, title and interest in and to the Trademark, together with the goodwill associated therewith and symbolized thereby, and in and to any and all renewals thereof;
- (b) all rights of any kind whatsoever of Assignor accruing under the Trademark provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world; and
- (c) any and all claims and causes of action with respect to the Trademark, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

**SUCCESSORS AND ASSIGNS:** This Trademark Assignment shall be binding upon and shall inure to the benefit of Assignor and Assignee and their respective successors and assigns.

**GOVERNING LAW:** This Trademark Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Trademark Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Illinois, without giving effect to any choice or conflict of law provision or rule (whether of the State of Illinois or any other jurisdiction).
