TRADEMARK ASSIGNMENT AGREEMENT

United States

This TRADEMARK ASSIGNMENT AGREEMENT ("Trademark Assignment"), dated as of 13/11/2018, is made between TSG Interactive Services Limited, a company incorporated under the laws of the Isle of Man, and whose registered office is at Douglas Bay Complex, King Edward Road, Onchan, Isle of Man IM3 1DZ ("TSG") and Rational Intellectual Holdings Limited, a company incorporated under the laws of the Isle of Man, and whose registered office is at Douglas Bay Complex, King Edward Road, Onchan, Isle of Man IM3 1DZ ("RIHL").

WHEREAS, TSG and RIHL have agreed that TSG shall assign to RIHL the US trade mark application number 87767872 and have agreed to execute and deliver this Trademark Assignment, for recording with the United States Patent and Trademark Office.


WHEREAS, TSG is the owner of all right, title, and interest in, under, and to the trademark in Schedule A (hereinafter the "Trademarks"); and


WHEREAS, RIHL desires to acquire the Trademarks, along with the goodwill of the business pertaining thereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, TSG hereby assigns unto RIHL all right, title, and interest in, under, and to the Trademarks therefore, together with the goodwill of the business symbolized by the Trademarks, and including, without limitation, all common law and foreign rights in and to the Trademarks, and the right to sue and recover for, obtain injunctive relief for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringements or dilution of or damage or injury to the Trademarks, to be held and enjoyed by RIHL, its successors and assigns, to the same extent that such would have been held and enjoyed by TSG had such assignment not been made. TSG hereby agrees to execute any additional documents to accomplish this assignment.

TSG is assigning the Trademarks to RIHL, along with that portion of the on-going and existing business to which the Trademarks pertain, as required by Section 10 of the Trademark Act (15 U.S.C. §1060).
