TRADEMARK ASSIGNMENT

ASSIGNOR hereby sells, grants, conveys, assigns, transfers and delivers to ASSIGNEE all right, title and interest in and to the Trademarks, together with the goodwill and common law rights connected with the use thereof and symbolized thereby, and all registrations, applications and renewals for any of the foregoing, and including all claims, causes of action and rights to sue, seek and obtain injunctive relief and recover damages for past, present and future infringement, misappropriation, dilution or other violation thereof.
2. At the request and expense of each party, from time to time, if necessary, each of the parties hereto shall execute and deliver all such further assignments or other instruments of conveyance and transfer, and shall take such further action as the other party may reasonably request to accomplish and record this Trademark Assignment.
3. ASSIGNOR authorizes the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable country outside the United States, to record this Trademark Assignment and the ASSIGNEE as the assignee and owner of any and all of ASSIGNOR's rights in the Trademarks.
4. Each of ASSIGNEE and ASSIGNOR, by its execution of this Trademark Assignment, hereby acknowledges that the rights and remedies of each party under the Purchase Agreement will not be deemed to be enlarged, modified or altered in any way by such execution and acceptance of this instrument. To the extent the terms and provisions of this Trademark Assignment conflict with the Purchase Agreement, the terms and provisions of the Purchase Agreement shall govern. All capitalized terms used but not defined herein shall have the meanings assigned to them in the Purchase Agreement
5. This Trademark Assignment will be binding upon and will inure to the benefit of the parties hereto and their respective successors and permitted assigns.


6. This Trademark Assignment shall be governed in all respects, including validity, interpretation, and effect in the manner set forth in Section 10.13 of the Purchase Agreement, which is incorporated herein by reference mutatis mutandis.
7. This Trademark Assignment may be executed in two or more counterparts, each of which will be deemed an original, but all of which together will be deemed to be one and the same agreement. A signed copy of this Trademark Assignment delivered by facsimile, e-mail or other means of electronic transmission will be deemed to have the same legal effect as delivery of an original signed copy of this Trademark Assignment.




