## SERVICE MARK ASSIGNMENT AGREEMENT

ASSIGNOR hereby agrees, without further consideration therefor, to execute, acknowledge, and deliver, or cause to be executed, acknowledged, and delivered, such further instruments and documents and to perform such further acts as may be reasonably requested by ASSIGNEE to effectuate more fully the assignment of the MARKS herein.




