TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of February 1, 2019, by Stonegate Asset Company II, LLC, a Delaware limited liability company (“Grantee”).

WITNESSETH:

WHEREAS, Grantee and CSC Operating Company, LLC, a Delaware limited liability company (“Grantor”), entered into that certain Grant of Security Interest in United States Trademarks dated as of October 30, 2018 (the “Security Agreement”; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement), pursuant to which Grantor granted a security interest to Grantee in, among other things, all of Grantor’s right, title and interest in and to the United States trademark number 2036021 registered on February 4, 1997 (the “Mark”); and

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on October 31, 2018, at Reel 6470, Frame 0841; and

WHEREAS, Grantee no longer has an interest in the Mark; and


WHEREAS, Grantor has requested that Grantee release its lien on the Mark and reassign the same to Grantor;
