THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of February 1, 2019, by Stonegate Asset Company II, LLC, a Delaware limited liability company ("Grantee").

WHEREAS, Grantee no longer has an interest in the Marks; and


WHEREAS, Grantor has requested that Grantee release its lien on the Marks and reassign the same to Grantor;
