RELEASE OF TRADEMARK COLLATERAL

This RELEASE OF TRADEMARK COLLATERAL ("Release") is made and effective as of February 7, 2019 by FIRST TENNESSEE BANK NATIONAL ASSOCIATION (the "Lender"), a national banking association, as secured party under the Security Agreement referred to below, in favor of MUNRO & COMPANY, INC., an Arkansas corporation (the "Pledgor").

RECITALS:

WHEREAS, Pledgor executed a Trademark Security Agreement with Lender dated as of February 5, 2010 (the "Security Agreement"), pursuant to which Pledgor pledged and granted a security interest to the Lender in and to all of the right, title, and interest of Pledgor in certain Trademark Collateral (as defined below); and

WHEREAS, in connection with said the Security Agreement, documentation was recorded with the United States Patent and Trademark Office at Reel 004169, Frame 0001 on March 17, 2010; and

WHEREAS, the Lender has agreed to release all its liens on the trademarks and trademark applications identified on Exhibit A attached hereto and made a part hereof, and all rights of Pledgor in any license agreements of Pledgor (the "Trademark Collateral") and to reconvey any and all rights in the Trademark Collateral to the persons legally entitled thereto.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Lender hereby releases all of its rights in and to the Trademark Collateral and reconveys to the persons legally entitled thereto all of the Lender's right, title and interest in and to the Trademark Collateral, all without warranty or representation of any kind.

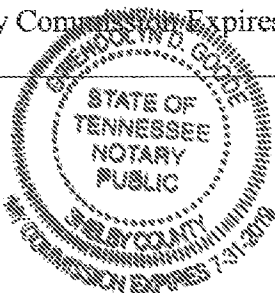
