## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of February 11, 2019 (the “Effective Date”), is made by Western Alliance Bank, an Arizona corporation (the “Lender”), in favor of Imagevision.net, LLC, a Delaware limited liability company (the “Grantor”).

WHEREAS, reference is made to that certain Loan and Security Agreement, dated as of March 16, 2017 (as amended, amended and restated, or otherwise modified from time to time, the “Loan Agreement”) between Lender, Grantor, Invoice Cloud, Inc., and such other parties named therein;

WHEREAS, pursuant to the Loan Agreement, the Grantor and the Lender entered into that certain Intellectual Property Security Agreement, dated as of March 16, 2017, (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, to secure the Obligations under the Loan Agreement, the Grantor granted to the Lender a security interest in all right, title and interest of Grantor in any of the following, whether then existing or thereafter acquired or created in any of the following property (collectively, the “Trademark Collateral”): (i) trademark and service mark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Grantor connected with and symbolized by such trademarks (collectively, the “Trademarks”), including the trademark and service mark registrations and applications set forth on Schedule 1 attached hereto, (ii) claims for damages by way of past, present and future infringement of any of the rights included above, with the right, but not the obligation to sue for and collect such damages for side use or infringement of the intellectual property rights identified above, (iii) licenses or other rights to use any of the Trademarks, (iv) amendments, renewals and extensions of any of the Trademarks, and (v) proceeds and products of the foregoing, including without limitation all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing; and

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on March 20, 2017 at Reel/Frame 6014/941.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement.

2. Release. The Lender hereby releases, discharges, terminates and cancels all of its security interest in all right, title or interest in and to the Trademark Collateral, including the trademark and service mark registrations and applications set forth on Schedule 1 attached hereto. If and to the extent that the Lender has acquired any right, title or interest in and to the Trademark Collateral under the Security Agreement or otherwise, the Lender hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.

3. Termination. The Lender hereby terminates and cancels the Security Agreement.

4. Further Assurances. The Lender agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
