**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of February 8, 2019, by **JEFFERIES FINANCE LLC**, a Delaware limited liability company, (the “Collateral Agent”) in favor of **PREFERRED UNLIMITED ASSETS, LLC**, a Delaware limited liability with an address at 100 Matsonford Road, Suite 101, Radnor, Pennsylvania 19087 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into the following Notices of Grant of Security Interest in Trademarks with the Collateral Agent (collectively, the “Trademark Security Agreements”):

- 1) Notice of Grant of Security Interest in Trademarks, dated July 31, 2014, with the Collateral Agent, notice of which was recorded on August 1, 2014 at the United States Patent and Trademark Office at Reel 5335, Frame 0355.
- 2) Notice of Grant of Security Interest in Trademarks, dated February 25, 2015, notice of which was recorded on February 25, 2015 at the United States Patent and Trademark Office at Reel 5466, Frame 0341;
- 3) Supplemental Notice of Grant of Security Interest in Trademarks, dated June 18, 2015, notice of which was recorded on September 30, 2015 at the United States Patent and Trademark Office at Reel 5641, Frame 0365 (and a corrective notice was recorded at Reel 5659, Frame 0826);
- 4) Supplemental Notice of Grant of Security Interest in Trademarks, dated August 14, 2015, notice of which was recorded on September 30, 2015 at the United States Patent and Trademark Office at Reel 5634, Frame 0371 (and a corrective notice was recorded at Reel 5680, Frame 0661); and
- 5) Supplemental Notice of Grant of Security Interest in Trademarks, dated October 13, 2015, notice of which was recorded on November 3, 2015 at the United States Patent and Trademark Office at Reel 5659, Frame 0911.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of its right, title and interest in, to and under its Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.

WHEREAS, the Collateral Agent has agreed to terminate and release its Security Interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantor, including the goodwill of the business symbolized thereby, and assigns,

transfers and conveys to Grantor the Security Interest in and to all of its right, title and interest in, to and under the Trademark Collateral.
