THIS IS TO CERTIFY THAT:

FIRST: "Painful Pleasures, Inc., a Maryland corporation," was formed on March 5, 2015 (the "Converting Corporation") and, by virtue of these Articles of Conversion filed for record herewith, is converting (the "Conversion") to "Painful Pleasures, LLC, a limited liability company," under the general laws of the State of Maryland (the "Converted Entity"), on the terms and conditions set forth herein.

SECOND: Upon the completion of the Conversion in accordance with the Maryland General Corporation Law, the Converted entity shall, for all purposes of the laws of the State of Maryland, continue as the same entity as the Converting Corporation, and the Conversion will have the effects set forth herein and in the Maryland General Corporation Law- Upon the completion of the Conversion:

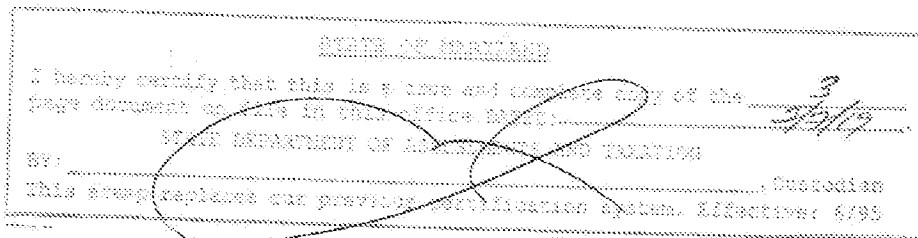
(a) All outstanding shares of common stock of the Converting Corporation (the "Converting Corporation Common Stock"), shall, without any action on the part of any stockholder of the Converting Corporation, be converted into and exchanged for the entire Membership Interest in the Converted Entity.

(b) No shares of stock of the Converting Corporation of any class or series other than Converting Corporation Common Stock are issued or outstanding.

THIRD: The terms and conditions of the Conversion were advised, authorized and approved by the Converting Corporation in the manner and by the vote required by the laws of the State of Maryland and the certificate of incorporation and Bylaws of the Converting Corporation.

FOURTH: These Articles of Conversion shall become effective upon filing.

FIFTH: The undersigned acknowledges these Articles of Conversion to be the act and deed of the Converting Corporation and, further, as to all matters or facts required to be verified under oath, the undersigned acknowledges that, to the best of his knowledge, information and belief, these matters and facts relating to the Converting Corporation are true in all material respects and that this statement is made under the penalties of perjury.
