RECORDABLE TRADEMARK ASSIGNMENT

NOW THEREFORE, in consideration of the mutual covenants contained in the Transfer Agreement, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns, and transfers to Assignee, and Assignee hereby accepts, Assignor's entire right, title, and interest in and to the Marks, and any registrations and/or applications for registration of the Marks, together with the goodwill of the business symbolized by the Marks, and the rights, if any, to sue or bring other actions for past, present or future infringement thereof throughout the world, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns and legal representatives, as fully and entirely as the same would have been held or enjoyed by Assignor if this Assignment had not been made.

Assignor hereby authorizes the Commissioner of Patents and Trademarks of the United States, as well as any official of any countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Marks and title thereto as the property of Assignee, its successors and assigns, in accordance with the terms of the Transfer Agreement.
