TERMINATION OF PATENT AND TRADEMARK SECURITY AGREEMENT

WHEREAS, pursuant to a certain Patent and Trademark Security Agreement dated November 10, 2014, between Grantor and WELLS FARGO BANK, NATIONAL ASSOCIATION ("Wells Fargo") with offices located at 1 South Broad Street, 3rd Floor, Philadelphia, PA, 19107, Grantor granted to Wells Fargo a security interest in and to the Marks, the registrations thereof, and the goodwill associated therewith;

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises and other good and valuable consideration and intending to be legally bound hereby, Wells Fargo hereby agrees as follows:

1. Effective as of the date hereof, the above-referenced Patent and Trademark Security Agreement is hereby terminated, and of no further force or effect.
2. Wells Fargo hereby releases its security interest and conveys back to Grantor all of Wells Fargo's interest in and to the Marks, the registrations thereof and the goodwill associated therewith.
3. Wells Fargo agrees to execute such statements or other documents, at Grantor's expense, as may from time to time be determined to be reasonably necessary, to evidence the release of any and all liens or interests of record in the Marks.
