**CERTIFICATE OF AMENDMENT OF
AMENDED AND RESTATED
CERTIFICATE OF INCORPORATION OF
PROSPERWORKS, INC.**

ProsperWorks, Inc., a corporation organized and existing under the laws of the State of Delaware (the "*Corporation*"), hereby certifies as follows :

1. The name of the Corporation is ProsperWorks, Inc. The Corporation was originally incorporated under the name "Mobius Media Group, Inc." The Corporation's original Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on December 28, 2011.

2. This Certificate of Amendment (this "*Certificate of Amendment*") amends the provisions of the Corporation's Amended and Restated Certificate of Incorporation set forth below.

3. This Certificate of Amendment was duly adopted in accordance with Section 242 of the General Corporation Law of the State of Delaware.

4. Article I of the Corporation's Amended and Restated Certificate of Incorporation is hereby amended to read in its entirety as follows:

"The name of the Corporation is Copper CRM, Inc."

5. Section 1(c) of Article IV of the Corporation's Amended and Restated Certificate of Incorporation is hereby amended to read in its entirety as follows:

"(c) "*Corporation*" shall mean Copper CRM, Inc."
