TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment") is made by Prefco Corp., a Delaware corporation ("Assignor"), on February 11, 2019, but effective for all purposes as of December 21, 2018 (the "Effective Date"), in favor of Cloverdale Foods Company, a North Dakota Corporation ("Assignee"), having its principal place of business at 3015 34th St. NW, Mandan, ND 58554.

WHEREAS, pursuant to that certain Asset Purchase Agreement (the "Purchase Agreement") by and between Blue Ribbon, LP, a Texas limited partnership ("Blue Ribbon"), and Assignee dated as of the Effective Date, Blue Ribbon agreed to sell, assign, transfer and convey to Assignee all of Blue Ribbon's right, title and interest in and to certain trademarks, including those trademarks listed on the attached Schedule 1 (those trademarks listed on the attached Schedule 1 being referred to herein collectively as the "Trademarks"); and

WHEREAS, on the Effective Date, Blue Ribbon executed and delivered to Assignee that certain Assignment of Marks, Patents, Copyrights and Purchased Property Rights dated as of the Effective Date (the "Blue Ribbon Assignment"), evidencing (among other things) the sale, assignment, transfer and conveyance to Assignee all of Blue Ribbon's right, title, and interest in and to certain trademarks, including the Trademarks, together with the goodwill of the business symbolized by the Trademarks and all causes of action and the right to sue and recover for past, present and future infringements of said Trademarks;

WHEREAS, reference is made to that certain Trademark Assignment dated as of January 26, 2018, made by Prefco, Inc., a Texas corporation ("Prefco Inc."), to Blue Ribbon assigning all of Prefco Inc.'s right, title and interest in and to the Trademarks to Blue Ribbon, a copy of which was filed with the U.S. Patent and Trademark Office on October 3, 2018 (the "Prefco. Assignment");

WHEREAS, Assignor intended for the Prefco Assignment to assign, transfer and convey all of Assignor's right, title and interest in and to the Trademarks to Blue Ribbon, and for the Blue Ribbon Assignment to assign, transfer and convey all of Blue Ribbon's right, title and interest in the Trademarks to Assignee;

WHEREAS, the Prefco Assignment was mistakenly entered into in the name of "Prefco, Inc." instead of "Prefco Corp.";

WHEREAS, in order to avoid any uncertainty as to whether the Prefco Assignment effectively assigned, transferred and conveyed all of Assignor's right, title and interest in the to the Trademarks to Blue Ribbon in order for the Blue Ribbon Assignment to effectively assign, transfer and convey such rights in the Trademarks to Assignee, Assignor is executing this Assignment to evidence the assignment, transfer and conveyance of all of Assignor's right, title and interest in and to the Trademarks directly to Assignee to the extent such rights are not already vested in Assignee by virtue of the Prefco Assignment and Blue Ribbon Assignment;

NOW THEREFORE, be it known by all whom it may concern that for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns, transfers and conveys to Assignee for the territory of the United States of America and the entire world all of Assignor's right, title, and interest in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and all causes of action and the right to sue and recover for past, present and future infringements of said Trademarks, in each case to the extent such rights are not already vested in Assignee by virtue of the Prefco Assignment and Blue Ribbon Assignment.


