RELEASE AND TERMINATION
OF
SECURITY INTEREST IN TRADEMARKS

This RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is effective as of March 30, 2018, by **PATRIOT CAPITAL II, L.P.**, a Delaware limited partnership, and **PATRIOT CAPITAL III SBIC, L.P.**, a Delaware limited partnership (together, “Patriot Capital”), in favor of **MIMEO.COM, INC.**, a Delaware corporation (the “Released Party”).

WHEREAS, pursuant to the terms of that certain (i) Grant of Security Interest in Trademarks by and between Patriot Capital II, L.P. and the Released Party, as filed with the Assignment Division at the United States Patent and Trademark Office (“USPTO”) on May 15, 2013 at Reel 5028, Frame 0198 (the “2013 Security Agreement”) and (ii) Grant of Security Interest in Trademarks by and between Patriot Capital III SBIC, L.P. and the Released Party, as filed with the Assignment Division at the USPTO on March 31, 2016 at Reel 5763, Frame 0521 (the “2016 Security Agreement” and together with the 2013 Security Agreement, the “Security Agreements”), the Released Party granted to Patriot Capital a security interest in and lien on all its Collateral (as defined in the Security Agreements), together with the goodwill of the business symbolized thereby, including, without limitation, the trademarks identified on Schedule A attached hereto; and

WHEREAS, Patriot Capital wishes to release the security interest in and lien on all Collateral, including, without limitation, the trademarks identified on Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Patriot Capital states as follows:

Patriot Capital hereby terminates and releases its security interest in and lien on the Collateral, and Patriot Capital hereby assigns and transfers to the Released Party, without recourse or representation or warranty, express or implied, of any kind, all of its right, title, and interest in and to the Collateral together with the goodwill of the business symbolized thereby, including, without limitation, each of the trademarks applications or registrations identified on Schedule A attached hereto, effective as of the date set forth above.

This Release shall be governed by the laws of the State of Delaware and shall relate solely to the Security Agreements.

Patriot Capital understands and agrees that this Release may be recorded by or for the Released Party with the USPTO or any similar office or agency within or outside the United States.
