**RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

Dated as of February 12, 2019

WHEREAS, FSA STORE INC., a Delaware corporation, whose post office address is 240 West 37th Street, 6th Floor, New York, NY 10018 (“Grantor”) had granted, to secure the repayment of loans made under a Loan and Security Agreement, dated as of March 18, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the “Loan Agreement”), a security interest and mortgage in certain personal property assets of Grantor in favor of VENTURE LENDING & LEASING VII, INC., as Secured Party (“Secured Party”), a Maryland corporation having a mailing address of 104 La Mesa Dr., Suite 102, Portola Valley, CA 94028;

WHEREAS, pursuant to the Loan Agreement, the Grantor and Secured Party executed that certain Intellectual Property Security Agreement, dated as of March 18, 2015, and recorded in the United States Patent and Trademark Office on March 20, 2015 at Reel/Frame No. 005482/0249 (the “Intellectual Property Security Agreement”), wherein the Grantor granted to Secured Party a security interest and mortgage in certain personal property assets of Grantor, including without limitation all of Grantor’s right, title and interest in Grantor’s trademark and service marks, and any registrations, applications, and licenses thereof, as specifically listed on the attached “Schedule 1”, whether presently existing or hereafter arising or acquired, and all products and proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof for the full term of the trademark, and the goodwill associated therewith (all of the foregoing collectively, the “Trademarks”); and

WHEREAS, Secured Party wishes to release and retransfer to Grantor, without representation or warranty, all of Secured Party’s right, title and interest in and to the Trademarks, and the goodwill associated therewith.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, Secured Party, on behalf of itself, its successors, legal representatives and assigns, hereby, terminates, cancels, reassigns, relinquishes, releases and discharges all liens, security interests, and mortgages it has on and in the Trademarks, and reassigns, reconveys, and retransfers to Grantor, without representation or warranty of any kind, express or implied, free and clear of any claims by Secured Party, all of Secured Party’s right, title and interest in and to, without limitation, the Trademarks, the goodwill associated therewith, and all causes of action for past infringement, if any.
