RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”) is made as of February 8, 2019, by **BLACK DRAGON CAPITAL GROWTH INCOME, L.P.**, a Delaware limited partnership (“**Secured Party**”), in favor of **ENTERWORKS ACQUISITION, INC.**, a Delaware corporation (“**Grantor**”).


WHEREAS, pursuant to that certain Senior Secured Promissory Note, dated as of August 17, 2016, executed by Grantor in favor of Secured Party and that certain Intellectual Property Security Agreement (the “**Security Agreement**”), dated August 17, 2016, executed by Grantor in favor of Secured Party, and recorded in the records of the United States Patent and Trademark Office on August 17, 2016 at Reel/Frame 5860/0865, Grantor granted to Secured Party a continuing security interest in all of Grantor’s right, title and interest in, to and under the Trademarks (as defined in the Security Agreement), including the trademarks set forth on Schedule A hereto.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Secured Party hereby (a) terminates and releases all liens and security interests granted by Grantor in favor of Secured Party in the Trademarks and (b) assigns, transfers and delivers to Grantor all of its right, title and interest in and to the Trademarks to the extent that any such right, title and interest exists as of the date hereof. Secured Party hereby authorizes Grantor or its designee to make filings with the United States Patent and Trademark Office and take further actions necessary to evidence the release and termination of Secured Party’s security interests in the Trademarks. Secured Party hereby authorizes the governing body of the United States Patent and Trademark Office to record this Release.
