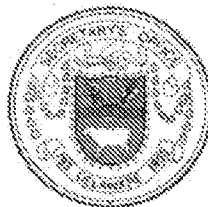



Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

**FIRST:** The name of the surviving corporation is Voke Tab, Inc., a Delaware corporation, and the name of the corporation being merged into this surviving corporation is Voke Tab, Inc., a Montana corporation.

**SECOND:** The Agreement and Plan of Merger has been approved, adopted, certified, executed, and acknowledged by each of the constituent corporations pursuant to Title 8 Section 252 of the General Corporation Law of the State of Delaware.

**THIRD:** The name of the surviving corporation is Voke Tab, Inc., a Delaware corporation.
