AMENDED AND RESTATED CERTIFICATE OF INCORPORATION

OF

NOVARTIS CONSUMER HEALTH, INC.

It is hereby certified that:

1. The name of the corporation is: Novartis Consumer Health, Inc. (the "Corporation").

a. The name under which the corporation was originally incorporated is Ciba Self-Medication, Inc.; and the date of filing the original certificate of incorporation of the corporation with the Secretary of State of the State of Delaware is December 20, 1994.

b. A Restated Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on December 26, 1996, for changing the name of the corporation from Ciba Self-Medication, Inc. to Novartis Consumer Health, Inc.

2. Pursuant to Sections 242 and 245 of the General Corporation Law of the State of Delaware, the Amended and Restated Certificate of Incorporation of the Corporation herein set forth has been duly adopted and approved by the Board of Directors and the stockholder of the Corporation on June 5, 2017.

3. The Amended and Restated Certificate of Incorporation amends in its entirety the Restated Certificate of Incorporation of this corporation with the provisions as follows:

FIRST: The name of this corporation is GSK Consumer Health, Inc. (hereinafter referred to as the "Corporation")

SECOND: The registered office of the Corporation in the State of Delaware is to be located at 2711 Centerville Road, Suite 400, in the City of Wilmington, 19808, County of New Castle and its registered agent at such address is Corporation Service Company.

THIRD The purpose or purposes of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of the State of Delaware.

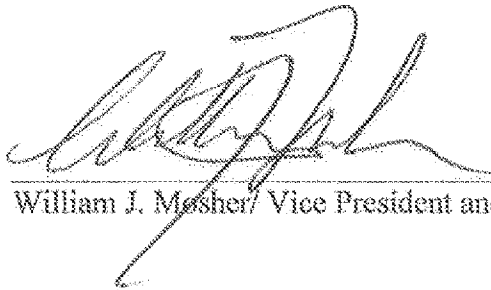
