Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, the undersigned corporations certify that:

1. The name and state of incorporation of each of the constituent corporations are Drink, Inc., a Delaware public benefit corporation ("*Drink Delaware*"), and Drink, Inc., a California corporation ("*Drink California*").
2. An Agreement and Plan of Merger dated as of July 18, 2018 has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations, in accordance with the provisions of Section 252(b) of the Delaware General Corporation Law.
3. The name of the corporation surviving the merger is Drink, Inc., a Delaware public benefit corporation.
4. In connection with the merger of Drink California into Drink Delaware, the Certificate of Incorporation of *Drink Delaware* shall remain unchanged.
5. The authorized stock of Drink California is 1,000,000 shares of Common Stock, par value \$0.001 per share.
