This Release of Security Interest in Trademarks (this "*Release*") is intended to operate as a release of all liens and security interests conveyed by Assignor to Assignee pursuant to the terms of the Trademark Security Agreement, and to reassign to Assignee all of Assignor's right, title, and interest acquired pursuant to the terms of such Trademark Security Agreement.
