**TERMINATION AND RELEASE OF
NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Notice of Grant of Security Interest in Trademarks (this "Termination"), dated as of December 20th 2018, is executed by Bank of America, N.A., as administrative agent (the "Administrative Agent"), in favor of Collabera Inc., a New Jersey corporation (the "Company").

RECITALS

A. Pursuant to that certain Notice of Grant of Security Interest in Trademarks, dated as of April 22, 2014 (the "Trademark Security Agreement"), by and between the Company and the Administrative Agent, the Company granted to Administrative Agent a security interest in the Trademark Collateral (defined below).

B. The Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on April 23, 2014, at Reel/Frame 5266/0718, to evidence the security interest granted under the Trademark Security Agreement.

C. The Trademark Security Agreement was amended by that certain First Amendment to Notice of Grant of Security Interest in Trademarks, dated as of May 31, 2015, by and between the Company and the Administrative Agent (the "First Amendment"). The First Amendment was recorded with the Trademark Division of the United States Patent and Trademark Office on June 2, 2015, at Reel/Frame 5538/0094, to amend and restate the security interest granted to the Administrative Agent under the Trademark Security Agreement, including to release the security interest in certain trademarks from the liens granted to the Administrative Agent by the Company.

D. Administrative Agent agrees to execute this Termination in order to further evidence the termination and release of its security interest in the Trademark Collateral (as defined below).

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby agrees as follows:

(a) Administrative Agent hereby expressly terminates and releases all of Administrative Agent's right, title and interest in, to and under the trademarks and trademark applications shown on Schedule 1 attached hereto (collectively, the "Trademark Collateral").

(b) Administrative Agent represents and warrants that it has the full power and authority to execute this Termination.

(c) Administrative Agent authorizes and requests the Trademark Division of the United States Patent and Trademark Office to record this Termination.


(d) From time to time after the date hereof, upon the Company's or Brillio, LLC's reasonable request, or upon the reasonable request of the Company's or Brillio, LLC's successors, assigns or other legal representatives, Administrative Agent agrees to provide the Company, Brillio, LLC or their successors, assigns or other legal representatives with any information and additional authorization and

documentation necessary to more fully and effectively effect the release of Administrative Agent's security interest in the Trademark Collateral.
