SHORT FORM TRADEMARK SECURITY AGREEMENT RELEASE

This **SHORT FORM TRADEMARK SECURITY AGREEMENT RELEASE** (this "Release") is granted as of June 29, 2012 by CME Group Index Services LLC (f/k/a CIMD, LLC), a Delaware limited liability company, located at 20 South Wacker Drive, Chicago, IL 60606 ("Secured Party"), in favor of Dow Jones Trademark Holdings LLC (f/k/a Dingo Smith Trademark Holdings LLC), a Delaware limited liability company, located at 1211 Avenue of the Americas, New York, NY 10036 (the "Grantor").

WITNESSETH:

WHEREAS, the Grantor is a party with the Secured Party to a Trademark Security Agreement dated as of March 18, 2010 (as amended, supplemented, extended, restated, or otherwise modified prior to the date hereof, the "Trademark Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor executed and delivered a Short Form Trademark Security Agreement (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "Short Form Security Agreement") granting the Secured Party a first priority continuing security interest in and lien on certain Collateral, as defined in the Trademark Security Agreement;

WHEREAS, the Short Form Security Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on March 23, 2010, at Reel 4172, Frame 0126, against certain Collateral identified on Schedule A hereto;

WHEREAS, the Secured Party has agreed to terminate and release its first priority continuing security interest in and lien on the Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby agrees as follows:

1. Release of Security Interest. The Secured Party hereby terminates, releases and discharges in favor of Grantor its first priority continuing security interest and lien upon the Collateral, including but not limited to the Collateral identified on Schedule A hereto, together with all products and proceeds thereof. Accordingly, the Trademark Security Agreement is hereby terminated and is of no further force and effect.

2. Reassignment. The Secured Party hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by the Secured Party, all of the Secured Party's right, title and interest in and to the Collateral.

3. Governing Law. THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK WITHOUT REFERENCE TO OR INCLUSION OF THE PRINCIPLES OF CHOICE OF LAW OR CONFLICTS OF LAW OF THAT JURISDICTION. ANY DISPUTE ARISING OUT OF


OR RELATING TO THIS RELEASE SHALL BE BROUGHT AND PROSECUTED IN ACCORDANCE WITH SECTION 14.6 OF THE PROJECT DIAMOND LICENSE AGREEMENT BETWEEN THE PARTIES.

4. Successors and Assigns. This Release shall be binding upon and inure to the benefit of the parties, all future holders of the Collateral, and the respective successors and assigns.


5. Counterparts. This Release may be executed in any number of counterparts, each of which shall be deemed an original and all of which together shall constitute one instrument.
